

TERMS OF USE FOR THE NEXT ROBE GENERATION PLATFORM

INTRODUCTION

The Next Robe Generation platform (hereafter referred to as "NRG") is an online educational and community platform operated by ROBE lighting s.r.o., Company ID: 640 88 791, located at Hážovice 2090, 75661 Rožnov pod Radhoštěm, Czech Republic, registered in the Commercial Register maintained by the Regional Court in Ostrava, file no. C 13864 (hereafter referred to as "ROBE"). The NRG platform is designed to connect students, professionals, university professors, and other experts in the field of lighting design with ROBE, its subsidiaries, and distributors worldwide. It facilitates education, sharing of professional experiences, and collaboration among users and organizers of professional courses and training. To use the NRG platform, users must agree to these terms of use.

REGISTRATION AND ACCOUNT

Access to the NRG platform is granted only to registered users. Registration can only be done upon invitation from ROBE, its subsidiaries, or ROBE distributors.

Registration requires entering mandatory information, including name, email, country, and professional details. Some information, such as artistic name, profile picture, and social media links, is optional. Each user is responsible for ensuring that the information in their profile is accurate and up to date. ROBE reserves the right to approve or deny user registration. A profile becomes active only after being approved by the platform administrator (ROBE master account).

USAGE OF THE PLATFORM

The NRG platform is intended solely for educational purposes and mutual sharing of professional experiences in the field of lighting technology and design. Users are allowed to create and edit their profiles, share their work, enroll in courses, and communicate with other users through forums or chat. Work uploaded to the platform (e.g., videos, designs) may only be shared with the explicit consent of the user. Users can export their profiles and share them outside the platform at their discretion.

USER RIGHTS AND OBLIGATIONS

Users agree to use the platform in accordance with legal regulations and these terms of use. Users must not upload content that is offensive, illegal, or violates third-party copyright. Users are responsible for the confidentiality of their account and access credentials. ROBE is not responsible for unauthorized use of an account by third parties.

PRIVACY POLICY

All personal data processed on the NRG platform is subject to ROBE's privacy policy, available on the platform's website. The privacy policy specifies in detail what data is collected, how it is used, and what rights users have concerning the processing of their personal data.

INTELLECTUAL PROPERTY

All content uploaded by users to the platform remains the property of the users. However, ROBE reserves the right to use these works for promotional purposes with the explicit consent of the user. The user grants ROBE a non-exclusive license to use the uploaded works for educational, promotional, and presentation purposes related to the NRG platform.

LIMITATION OF LIABILITY

The NRG platform is provided according to its purpose and available technical capabilities, without guarantees of uninterrupted availability, completeness, or error-free operation. ROBE is not liable for data loss, service interruptions, or any damage arising from the use of the platform. However, ROBE is committed to ensuring appropriate protection of personal data and data security in accordance with applicable legal regulations.

ACCOUNT CANCELLATION

Users can request to cancel their account at any time. Upon cancellation, all personal data will be deleted unless there is a legal reason to retain it. ROBE reserves the right to cancel a user's account if any violation of these terms of use is detected.

CHANGES TO THE TERMS OF USE

ROBE reserves the right to change these terms of use at any time. Users will be notified of changes via email or through notifications on the platform. Continued use of the platform after changes are posted constitutes acceptance of those changes.

CODE OF CONDUCT ON THE NRG PLATFORM

The NRG platform is an educational and community environment that requires mutual respect and appropriate behavior from all users. By using the platform, you agree to adhere to the following behavioral rules:

- **Harassment or Bullying:** Any form of targeted harassment, intimidation, or bullying of other users is strictly prohibited.
- **Discriminatory Language:** Any racist, sexist, homophobic, or other discriminatory language or actions targeting individuals based on their identity will not be tolerated.
- **Personal Attacks:** Criticizing or insulting others in a disrespectful or unconstructive manner is prohibited.

- **Provocative Behavior or Trolling:** Posting intentionally provocative, off-topic, or inflammatory content to elicit strong reactions or disrupt discussions is not allowed.
- **Spamming or Excessive Promotion:** Excessive posting of irrelevant or promotional content that distracts from the primary educational purpose of the platform is not permitted.
- **Dissemination of Misinformation:** Deliberate spreading of false or misleading information, especially if undermining the educational goals of the platform, is strictly prohibited.
- **Plagiarism:** Sharing content, photographs, videos, or works of other authors without proper attribution or claiming someone else's work as one's own will not be tolerated.
- **Inappropriate Language or Content:** Use of vulgar language, offensive jokes, or posting inappropriate images or videos not suitable for an educational environment is prohibited.
- **Violation of Privacy:** Sharing personal information of other users without their consent is not allowed.
- **Disrespecting Intellectual Property:** Sharing or distributing copyright-protected materials without permission or violating other intellectual property rights is prohibited.
- **Disruption of Educational Environment:** Behavior that disrupts discussions, mentoring, or the educational environment, such as deliberately interrupting discussions in individual courses, conversations, or other educational activities, is not allowed.
- **Refusal to Respect Communication Rules:** Ignoring platform administrators' instructions regarding respectful communication or unwillingness to discuss politely is unacceptable.
- **Unauthorized Commercial Promotion:** Offering products, services, or business opportunities without the platform's approval is not allowed.
- **Impersonation:** Impersonating someone else with the intent to harm or deceive other users is prohibited.

CONSEQUENCES OF VIOLATING THE RULES

In the event of a violation of this code, ROBE reserves the right to block or cancel the user's account and take further appropriate actions depending on the severity of the violation.

CODE OF CONDUCT AT NRG EVENTS AND TRAININGS

Participants in NRG also meet at events, trainings, and other activities that promote skill development and community connection. To ensure a professional, respectful, and inclusive environment, all participants are required to follow these rules:

- **Respect and Courtesy to Other Participants:** Participants must show respect to all other members of the NRG platform and event attendees. Discriminatory behavior, harassment, bullying, and any form of personal attacks will not be tolerated.
- **Professionalism and Responsibility:** Participant behavior must be professional and responsible. Participants are required to follow the instructions of organizers and moderators during events and trainings. Any inappropriate or disruptive behavior may result in removal from the event.
- **Respect for Communication and Discussion Rules:** Participants must respect the communication and discussion rules set by the organizers. Provocation, trolling, or intentional disruption of discussions is unacceptable and may lead to removal from the event.
- **Adherence to Intellectual Property Principles:** Plagiarism, unauthorized copying, and dissemination of others' works without attribution are prohibited. Participants must respect the intellectual property rights of others.
- **Responsible Alcohol Consumption:** Responsible behavior is required at NRG events, particularly regarding alcohol consumption. Any behavior resulting from excessive drinking that endangers others or disrupts the event will lead to exclusion from the event.
